



四、低碳园区建设目标 Targets in Low Carbon Development



四、低碳园区建设目标 Targets in Low Carbon Development

- 1) 万元生产总值碳排放强度2015年比2010年降低21%;
1) CO₂ emission per capita of GDP reduces 21% in 2015 compared to 2010;
- 2) 万元生产总值能耗2015年比2010年降低18%;
2) Energy Consumption per capita of GDP reduces 18% in 2015 compared to 2010;
- 3) 天然气占一次能源比例达到 33%;
3) Natural gas takes up 33% of primary energy source;
- 4) 可再生能源占全部能源比例达到1. 5%;
4) Renewable energy takes up 1. 5% of total energy source;
- 5) 高新技术企业工业总产值占全区工业总产值比重40%;
5) Industrial output of hi-tech enterprises takes up 40% of total industrial output;



四、低碳园区建设目标 Targets in Low Carbon Development

- 6) 第三产业增加值超过1000亿元，比重超过30%;
6) The added value of tertiary industry surpasses 100 billion YUAN, takes up more than 30% of total industrial added value;
- 7) 工业生产、居民生活绿色照明覆盖面达到80%以上;
7) Green lightning coverage ration achieves 80% in industrial production and household usage;
- 8) 新建绿色建筑开工面积达到100万平方米;
8) New green building areas achieves 1 million m²;
- 9) 重点企业开展清洁生产审核比率100%;
9) Key companies Cleaner Production Verification ration achieves 100%;
- 10) 重点能耗企业开展能源审计比率100%;
10) Key energy consumption companies Energy Audit ration achieves 100%;
- 11) 创建2个低碳小区
11) Establish 2 low carbon residential areas.
