





# Selected regional MPA networks (country coverage)

## Brief background of NEAMPAN

- SOM-16 (2011): a project proposal on "Strengthening Subregional Cooperation to Address Environmental Challenges related to Transboundary Marine Pollution"
- ▶ Expert Consultation Meeting (2012): cooperation among Marine Protected Areas (MPAs) becomes the main focus of NEASPEC activities regarding marine environment
- Research on MPAs (2012): benefits of the regional networks and potential roles of a subregional MPA network, various issues to overcome
- SOM-17 (2012): endorsed the proposal for launching North-East Asian Marine Protected Areas Network (NEAMPAN)
- ▶ NEASPEC/ NOWPAP workshop on MPA (2013): Identifying specific approaches and programme areas
- ▶ SOM-18 (2013): endorsed TOR of NEAMPAN

#### Terms of Reference of NEAMPAN

- Goal of the Network: is to establish an effective, functional representative network of MPAs in North-East Asia for conservation of marine and coastal biodiversity and more efficient MPA management.
- Geographical scope of the Network: all seas of NEA target MPAs at initial stage and later stage
- Network membership: management authorities, national institutions, NGOs, relevant programmes, ...
- Secretariat and programme operation of the Network: Steering Committee, Advisory Committee, and Secretariat
- Objectives and activities of the Network
- Thematic areas


## Objectives and activities of the network

- Ecological network of MPAs
- Building and sharing knowledge
  - Network meetings, dissemination of information
  - Research and monitoring
- Capacity building in MPA management, conservation policies, meeting global commitments, etc.,
  - Training courses
- Regional cooperation / networking
  - Network meetings, dissemination of information
  - Networking with regional and global mechanisms

#### Thematic areas

- **▶ Effective MPA** management
  - e.g. local participation, public awareness, prevention of 'paper parks,' and MPA database
- Sustainable use of marine resources
  e.g., aquaculture, seafood security, fish stocks restoration;
- Protection of key marine animals
  e.g., Spotted Seals, Black-faced Spoonbills and Sea Turtles, and their habitats;
- ► Collaboration with other relevant programmes, networks and projects
  - e.g., NOWPAP, YSLME and EAAFP


## Setting up NEAMPAN framework

- Categories set by individual countries


## Definition and selection of target MPAs



## Network membership

- governments
- membership with separate categories
  - Members (management body of MPAs, private and public bodies responsible for planning and strategies of MPA management) and partners
  - Full members (MPAs that met criteria) and Associate members (NGOs, CSO, research, governments, donors, any individuals)
- general membership
  - MPA managers, experts, and resource agencies, etc

- Budgetary matters
  - Source of funding
