



Europe and Australia

- French National Centre for Scientific Research (ICARE-CNRS)
 - > Sino-French Joint Workshop on Atmospheric Environment, a total of eight editions successfully held till 2024.
- Technical Reference Center for Air Pollution and Climate Change (CITEPA)
 - ➤ Sino-French Center of Air Pollutants and Greenhouse Gas Emission Inventories (SFCAGEM), promoted the exchanges and cooperation in atmospheric environment and climate change
- Australia-China Centre for Air Quality Science and Management (ACC-AQSM)
 - Established in 2014
 - A Total of 18 members from Mainland China, HKSAR and Australia, including Queensland University of Technology, Monash University, HKU, etc.









Asian Countries

- Thailand: Promoting the development of "Asia-Pacific Platform for Regional Green Development and Environmental Technology Innovation"
 - Establishing partnerships with National Innovation Agency (NIA) of Thailand, Siam Cement Group, Strategy 613, etc.
 - Presenting cutting-edge scientific and technological achievements in prominent events including the Thailand Green Technology Exhibition, Startup x Innovation Thailand Expo 2024, etc.
 - Setting up a "Clean Air Bangkok" project with Bangkok Metropolitan Administration, the Federation of Thai Industries, Chulalongkorn University, etc., in order to provide technical assistance and consulting services on the improvement of air quality in Bangkok.







Asian Countries

■ Pakistan

- A **joint project** was **agreed** upon to assess Punjab' s air pollution control needs and facilitate technical exchanges. CRAES will lead the drafting of the **project proposal**.
- Identified **three key collaborative pathways**, including the signing of a MoU between CRAES and relevant departments of Pakistan's Punjab Province, the joint establishment of a "Belt and Road" laboratory, and collaborative efforts to secure funding support for projects.

■ Nepal

- Signed the first MoU on South Asia Regional Cooperation with ICIMOD, addressing critical regional gaps.
- Cooperation covers the following priority areas, including Air Pollution Prevention & Control, Biodiversity Conservation,
 Mountain Community Development. Pragmatic progress has been seen in joint research initiatives, application of international project, hosting of global conferences, capacity-building and training programs, and personnel exchanges




Air Quality Governance Experience-Sharing in Pakistan

Cooperation with Mongolia

■ Dust Sand Storm Cooperation

- Promoted a cooperation platform involving China, Japan, ROK and Mongolia, to jointly tackle the problem of Dust Sand Storm in the Northeast Asia Region (based on the Asian Regional Cooperation Project fund support from Chinese Government)
- Conducting academic exchanges with Mongolian University of Life Sciences, National Agency of Meteorology and Environment, etc.
- Conducting on-site research on the causes and solutions of the ecological degradation in the source region of dust sand storm
